ADVOCACY HAS BEEN AT THE CORE OF SANTA MONICA BAYKEEPER'S WORK SINCE SANTA MONICA BAYKEEPER'S FOUNDING. THIS WORK CONSISTS OF BOTH PROMOTING PROGRESSIVE REGULATION BY VARIOUS LOCAL, STATE, AND FEDERAL AGENCIES IN ADDITION TO ENFORCING OUR CURRENT LAWS.

SANTA MONICA BAYKEEPER PLAYED A MAJOR ROLE IN REACHING AN AGREEMENT WITH THE U.S. ENVIRONMENTAL PROTECTION AGENCY IN 1999 TO ESTABLISH TOTAL MAXIMUM DAILY LOADS (TMDLS) FOR LOS ANGELES AND VENTURA COUNTIES. TMDLS ARE A COMPONENT OF THE CLEAN WATER ACT THAT REQUIRES THE GOVERNMENT TO REGULATE POLLUTANTS AT A WATERSHED LEVEL WHERE WATERS ARE

SANTA MONICA BAYKEEPER'S KELP PROJECT HAS WORKED SINCE 1997 TO RESTORE AND MONITOR VITAL KELP FOREST HABITAT IN SANTA MONICA BAY.

IN 2008, THE KELP PROJECT PARTNERED WITH THE VANTUNA RESEARCH GROUP OF OCCIDENTAL COLLEGE TO PERFORM STATE ENDORSED MONITORING OF OUR COASTAL RESOURCES USING COOPERATIVE RESOURCE ASSESSMENT OF NEARSHORE ECOSYSTEMS (CRANE) SURVEYS. THE EXECUTION OF THIS PROJECT HAS GENERATED A COMPREHENSIVE DATA SET DESCRIBING THE EXTANT RESOURCES OF THE LOS ANGELES COUNTY COASTLINE. THIS DATA WILL BE OF DIRECT BENEFIT TO THE SOUTH COAST STUDY REGION UNDER THE MARINE LIFE PROTECTION ACT
