This work consists of both promoting progressive regulation by various local, state, and federal agencies in addition to enforcing current laws. Enforcement of the Clean Water Act and related environmental laws is the Organization's chief pursuit.

4b (Code: ) (Expenses \$ 266702. including grants of \$ ) (Revenue \$ ) Marine Program - The Marine Program works to promote ecosystem health and resiliency of Los Angeles County's coastal waters through monitoring and research, hands-on restoration and education, with frequent outreach and advocacy work relating to the operations of the State Coastal Conservancy, State Lands Commission, Ocean Protection Council, California Coastal Commission, Santa Monica Bay Restoration Commission, Los Angeles Long Beach Harbor Safety Committee, United States Coast Guard, California Department of Fish and Game, National Oceanic and Atmospheric Administration, National Marine Fisheries Service, National Marine Sanctuaries, United States Mineral Management Service, and the California Oil Spill Prevention and Response Technical Advisory Committee.

4c (Code: ) (Expenses \$ 102112. including grants of \$ ) (Revenue \$ ) Watershed Program - The Watershed Program encompasses water quality monitoring, public education, and litigation support. The program is focused on identifying and addressing sources of pollution that impact the Los Angeles and San Gabriel Rivers, Ballena Creek, and ultimately the Santa Monica and San Pedro Bays and the Pacific Ocean. Over its 15+ year history, the program has taken a holistic approach, conducting river and coastal restoration and monitoring projects that help to improve water quality and viable habitats in the watersheds of the Los Angeles Basin.
